



#### **Andre McCain** Founder & CEO HalfSmoke

Andre McCain is the founder of HalfSmoke Restaurant and was recently named as a 2021 40 under 40 recipient by the Washington Business Journal.

A native of Washington DC's Ward 7, at age 16 Andre founded his first company, Urbanfly.com, a fashion e-commerce website focused on linking consumers with brand-name clothing from suppliers around the world, which he ran from 2002-2006. In 2003, he



was honored by The Network for Teaching Entrepreneurship (NFTE) as a National Young Entrepreneur of the Year. Andre earned a Bachelor of Arts in Economics from Morehouse College in Atlanta, Georgia, in 2008. During those years he also studied abroad at the London School of Economics and Political Science, at Peking University in Beijing, China, and with the Institute for the International Education of Students in Barcelona, Spain.

After graduation, Andre moved to New York to join UBS Investment Bank as an analyst focusing on real estate, lodging and leisure. Then in 2010, after completing the analyst program during the height of the financial crisis, he returned to Washington, DC, and was eventually tapped by SL Green Realty Corporation in New York to become an associate in real estate acquisitions and structured finance investments, a role he held until 2013, when he became vice president of real estate acquisitions and development for Princeton Holdings, LLC, in Manhattan.

After working for three of the nation's top real estate and investment firms, he was fueled by his belief that the restaurant business gives one the opportunity to make a profound impact on the lives of thousands of people daily. In 2013, he began to explore the world of successful, sustainably designed, fast casual restaurants, working to get insight into food preparation, service and customer engagement, while assisting with the opening of a new establishment. Despite the 4 a.m. wake up calls to begin prepping for the day's business in New York, as well as traveling back and forth to Washington on weekends to do restaurant work, he found the enthusiasm for launching his own restaurant in the Shaw neighborhood in Washington.

Andre's vision for HalfSmoke was to create the first restaurant of its kind, to fill the void for a premium offering of one of America's longstanding favorite foods, the sausage, which is the third-most consumed item in America. HalfSmoke is a welcoming restaurant of grand design that is typically associated with "destination" restaurants, where customers seek good food and a pleasing entertainment experience.

Andre is a proud alumnus of the NFTE class of 2003.


## Volunteers of the Year



Mary Blackford is the Founder of Market 7, Washington, DC's first Black-owned food hall that features Black-owned food and lifestyle businesses for the purpose of alleviating food and retail deserts in DC.

Mary graduated from Babson College with a BS in Business Management. As a student she also taught entrepreneurship courses to high school students



In 2019, Mary created a partnership with Whole Foods Market (Mid-Atlantic) to bring more Black-owned brands to their stores. Mary has also developed training partnerships with Google and the Greater Washington Urban League to provide entrepreneurial training in underserved communities in 2020-2021.



like Vaughn Acord, he secured his first hotel partnership during the pandemic of 2020 installing a boutique barber-studio & art gallery inside.



#### James Dawkins, Jr. Founder, Hawkeye NFTE Class of 2021

During the pandemic, James witnessed his parents' stress at managing their work and his 8-year old brother's distance learning at the same time. His brother was struggling, having to constantly pay attention to a screen. What if there was a way to remotely track his and other students' attention? Using Aduino software and python code, James created HawkEye, a camera that tracks the eyes of a child engaged in remote or distance learning. HawkEye



cameras can be used to assist low-income families, allowing their children to participate in remote learning unsupervised while they go to work. James, an honor roll student and member of the Science Nationals Honors Society, currently attends University of Maryland, College Park, majoring in Mechanical Engineering.
